- 5. Old Business:
- 5.1. Appointment of Secretary and Treasurer. Tabitha appointed Gene as Secretary and Cheryl as Treasurer. Both accepted the appointments.

Motion carried. After some discussion, it was agreed by consensus to keep the storage unit until at least June to determine where the Chamber's new home would be.
